# **BUILDING & INFRASTRUCTURE**

Based on current Department of Justice ADA regulations, this course will provide an overview of the regulation changes, effective dates, provisions for newly designed and constructed or altered facilities, and will discuss the scope of technical provisions. The training will also cover the ADA requirements for building accessibility along with key components that City/Town governments should consider when reviewing and/or implementing their ADA compliance. The Department of Justice recommends that all entities, regardless of size, have an ADA Coordinator or designated liaison. This training will provide valuable insight on the following aspects:
